During the past year, the Board of Education for Northern Ireland has continued to work on its

key functions namely:

• working with other Churches to develop a clear and shared vision of education shaped

by core values of the Christian faith

• advising Synod of developments in education policy in Northern Ireland

• representing the Church in work with the Department of Education and other

education bodies

• liaising with other Churches within the Transferors Representatives' Council

• supporting the Religious Education core syllabus in schools

This report aims to provide an overview of the activity of the Board of Education for Northern

Ireland, in seeking to achieve its core objectives during the year past and will cover the

following areas:

• Promoting the role of Christian faith in education

• Pursuing a revision of the Religious Education curriculum

• The work of the Education Authority

• The work of the Transferor Representatives' Council

• Church of Ireland schools

Faith in education

The Board is concerned by the voices in the media, politics and society which might question

the role of faith in education. The Board believes that a school is best served by a non-

denominational Christian ethos open to those of all faiths and none.

The Board has also been considering the findings of the Independent Review of Education in

Northern Ireland which was published in December 2023 and how it relates to the role of

Churches in education.

Religious Education Curriculum

The Board of Education supports the Transferor Representatives' Council in their pursuit of a

revision to the Religious Education Curriculum in Northern Ireland. The Board endorses the

position that Collective Worship is a Christian act and is vital in the retention of a Christian

ethos in all controlled and Church of Ireland schools.

Relationships and Sexuality Education

The Board is concerned with the direction of travel of an imposed part of the Relationship and

Sexuality Education curriculum concerning abortion and sexual reproduction for all school in

Northern Ireland. The high level of parental response to the Department of Education

consultation supporting the role of individual schools and their ethos in determining RSE

delivery is noted and welcomed. The Board has welcomed the advice published by the

Department of Education on this matter.

Education Authority

The Board extends its thanks to Rev Canon Amanda Adams and Miss Frances Boyd for their

dedication in representing our church as members of the Education Authority Board. Miss

Boyd completed her period of service in April this year and Canon Adams continues to serve

until April 2025.

The direct involvement of representation of the Church of Ireland in the work of the Education

Authority is very important as this body is responsible for the delivery of efficient education

services to meet the needs of children and young people through schools and youth services.

An independent review of the work of the Education Authority was published in June 2022 and

our church representatives have been involved in the shaping and delivery of the action plan to

address the issues and recommendations highlighted in the findings of the review. These

include:

• Internal and external reviews examining the key purpose of EA, its key services and

provision.

• The strategic alignment of budget to the identified priorities of the organisation

• The structure of the organisation

• Accountability and governance

• Ensuring that business practice aligns with the needs of stakeholders and customers.

Funding

The Board is deeply concerned that our education system is under-funded. They are particularly

concerned with the impact on children and wish to thank all teachers, staff and governors for

working in such difficult circumstances.

Special Educational Needs

The Board has been working with both the Department of Education and the Education

Authority on the exponential growth in the number of children and young people presenting

with Special Educational Needs which has created a major challenge in terms of suitable school

placements and the consequent resourcing in financial and human terms.

Transferor Representatives' Council

The TRC has continued to meet with a range of key partners in the education sector and political

parties to discuss key educational policy issues.

TRC has also been heavily involved at both strategic and operational levels in Area Planning

of education provision across Northern Ireland. The focus of this work in the past year has

been the ongoing delivery of actions contained within the current Area Plan and the

development of the strategic and operational aspects of the next Area Plan which will cover the

next three-year period.

TRC has been working with representatives of the Catholic Church to agree the conditions

required for the creation of schools jointly managed by Protestant and Catholic Churches. The

Working Group have agreed an ethos document, a guide to creating such a school and the

minimum conditions for such a school. They are currently working on a joint Scheme of

Management.

As the process of re-constitution of school Boards of Governors is now live, TRC are

supporting church nominators of Transferor Governors through the process. It is important that

all Transferor Governor positions are filled, and they recently held three seminars for clergy

and lay people to support the nomination. It is vitally important that churches play their role

in supporting the governance of schools.
