THE ARCHBISHOPS AND BISHOPS OF THE CHURCH OF IRELAND FLOOD APPEAL FUND DECEMBER 2023



The Church of Ireland, through the Representative Church Body (RCB), will run a Flood Relief scheme to support Church of Ireland parishes affected by flooding between the period January 2023 - November 2023. This scheme will open to parishes on Monday, 11 December 2023 and the closing date for receipt of applications is Friday, 12 January. The total amount available for this scheme is €50,000.00.

CONTRIBUTION AVAILABLE

Parishes will be invited to apply for a single once-off contribution of up to a maximum of $\pm 4,300 / \pm 5,000$ towards both capital and non-capital costs not covered by insurance. This may include a contribution towards the replacement of flooring, fixtures, and fittings. This scheme will consider applications to cover parish, parishioner and community costs arising from the impact of flooding. Depending on number of applications, applicants may not receive any/the full amount of contribution requested.

APPLICATION PROCESS

Applicants will be required to apply through the RCB, via the project manager, Rebekah Fozzard. Information that will be required as part of the application process include:

- Name
- When did the flooding occur
- Outline the details of the damage and cost to the parish
- Outline the response to the flooding by the parish
- Amount requested (noting maximum amounts available)
